Dear Dave:

It seems as though I have a great deal of items to write to you, since I have not answered many of your notes and I will very likely forget to answer some of the questions which you have written. I am glad to see that you will act as Chairman of the Constitution Committee and that we have received verbally the acceptance of Chun, Pyeatt, Albers and Jules Braunstein. I think your suggestion that Jules be included is definitely in line with what we want to accomplish. I feel that this letter and the carbon copies to each of the individuals involved, is sufficient to get this committee in operation. I do not feel that the committee should be much larger. I also do not feel that any expense should be incurred if all that is found by the committee is that a few words should be changed. I believe your suggestions, as to the revision of the Constitution of the Gulf Coast Section of the S.E.P.M. should definitely be considered, that you mentioned to me in your letter of October 17, 1960.

For the information of the other members of this committee, that are being formed through copies of this letter, I would like to list your suggestions along with a few of mine, which possibly the committee should consider: they are:

- (a) A program chairman should be appointed in the city in which the coming convention is to be held.
- (b) Vice President should actively solicit papers in addition to the Editor. The amount of the dues should be considered.
- (c) A simpler method for the acceptance of new members into the Organization.
- (d) The possibility that there should be no penalty for bona fide members as far as their standing, when they move from this Area.

(e) The possibility that under Article 5, Meetings, Section 2, concerning the unified meetings at the G.C.A.G.S. could be reconsidered.

I think it is a good possibility, that the Section Editor could possibly be one of the Coungil members and elected, rather than appointed. Any other ideas that you and your committee come up with, I would appreciate being kept informed. If there is anything else you think I should do along this line, in order to kick off the work on this committee, please let me know.
